1. A grade of "F" in the course
2. A notation on the transcript (remains the entire time student is enrolled at UGA & two years after incident)
3. Suspension for a semester (not including summer)
4. Permanent expulsion

A second violation results in a meeting with the Multiple Violations Review Board (MVRB) and the assignment of mandatory dishonesty transcript notation and except in unusual circumstances, one of the following:

1. Suspension for a semester (not including summer)
2. Dismissal
3. Permanent expulsion
